



## SSN TOKEN DIAMOND RESERVE VERIFICATION REPORT

**Report Date: February 25, 2025**

**Verification Period: February 18-24, 2025**

### EXECUTIVE SUMMARY

This independent verification report confirms the existence, quality, and secure storage of **40,000 carats** of certified Namibian diamonds that serve as physical backing for SSN Token. The verification team has conducted a thorough physical inspection of the entire diamond reserve and confirms that all 40,000 carats are properly secured in accordance with international security standards.

With a total fixed supply of 100,000 SSN Tokens, each token is backed by approximately 0.4 carats of authenticated Namibian diamonds. At current market valuations, this represents approximately \$1,240 USD in diamond backing per token.

### VERIFICATION METHODOLOGY

The verification process followed industry-standard protocols for diamond asset verification:

1. **Physical Inspection:** Complete visual inspection and random sampling of diamond inventory
2. **Weight Verification:** Electronic measurement of total carat weight using calibrated scales
3. **Authentication:** Gemological testing of diamond samples for authenticity and quality
4. **Documentation Review:** Examination of certification records and chain of custody documentation
5. **Security Assessment:** Evaluation of storage security protocols and insurance coverage
